### ***SET UP TIME***

Friday, August 18, 2017 Noon to 4pm

***All Vendors must arrive within these hours.***

### ***HOURS OF OPERATION***

4pm – 10pm, Friday, August 18, 2017

11 am – 10pm, Saturday, August 19, 2017

11am – 5pm, Sunday, August 20, 2017

### ***ELECTRICITY***

Electricity is provided. Please bring a 100 foot extension cord to access power. Vendor supply their own tent(s) to cover their designated area.

### ***LOAD OUT***

Anyone that tears down early will not be permitted to participate the following year. Vendors must remain open for business during the hours of operation. Vendor is responsible for leaving the site in a clean state.

### ***VEHICLES***

No vehicle may be operated within the festival grounds between:

Friday: 4 pm until end of entertainment

Saturday: 11 am until end of entertainment/fireworks

Sunday: 11 am until end of entertainment

### ***PERMITS & FEES***

A Vendor is responsible for permits if any, required by law, including Workers Safety Insurance Board Certificate.

### ***HEALTH***

The Vendor will conform to Health regulations. Vendor is responsible for proper disposal of all waste, including trash, grease, grey water and/or ash in their respective area, using facilities provided by the festival for disposal.

### ***SECURITY***

The festival will provide overnight security on the site. Mountain Man Music Festival, Calabogie Country Music Festival Inc. and Calabogie Blues & Ribfest Inc., (“Festival Companies”) are not responsible for loss or damage to Vendor’s site or contents.

### ***INDEMNITY & WAIVER***

Vendor agrees to indemnify and save the Festival Companies, including their volunteers, employees, agents, sponsors and affiliated parties, harmless from any claims, actions or causes of action arising as a result of any action or actions in connection with the sale and/or

distribution of Vendor's goods and wares.

The Festival is not responsible for any event or circumstance which may postpone, delay or cancel the Festival, or any damages whatsoever arising there from, nor shall it be held liable for a power or other services failure. If the Festival is cancelled, the Participation Fee will be refunded.

### **NO GUARANTEES**

The Festival Companies have committed significant money, advertising and human resources to promote ticket sales and solicit audience attendance. Actual attendance depends on many factors outside of the Festival's control, including weather. The Festival does not guarantee festival attendance numbers or the minimum amount of sales the Vendor will earn at the festival.

### **CANCELLATION**

The Festival may cancel this Agreement for any reason on giving the Vendor ten (10) days written notice, and upon receipt of such notice, the Festival shall provide the Vendor with a full refund of any payments made by the to the Festival as provided herein.

### **SUBCONTRACTING**

Under no circumstances shall the Vendor subcontract in whole or in part the concession granted to it herein.

### **VENDOR OUTSIDE FOOD**

Vendors may to bring outside food into the festival area for their own personal consumption. Vendors will present their ticket given to them in their onsite package. Upon entry, Vendor coolers and bags will be checked by the security guard on duty.

### **GENERAL**

This Agreement is governed by law.
